However, I do have some personal restrictions, as we all should concerning the issues addressed when it involves children, and more importantly, young individuals that I wish to influence or inspire! For example, I believe it is important to enlighten young people as to Bible teachings, also the history of our nation, while strictly adhering to truth and facts. I believe it is important to make people (both young and old) aware as to how the issues we encounter in daily life may affect us in the long term. However, what I saw in this video link was a child being **brainwashed** and turned into a mere tool for a political agenda. One would be hard pressed trying to convince me that the child in this video link has *any* idea what she is talking about, and what the ramifications are of what she is supposedly supporting.
